Organizational changes (Effective January 1, 2019)

1. Reorganization of Business Units and Product Divisions

(1) Establishment of Business Groups and realignment of Product Divisions

To ensure that its organization reflects its belief in addressing social imperatives and delivering value to society, DIC will establish new business groups based essentially on markets served and value provided. In addition, the classification within each business group will be broadened to facilitate the swift reallocation of management resources. The new business groups and their respective underlying business concepts and product divisions are as follows:

- Packaging & Graphic Business Group ("Packaging materials that bring safety and peace of mind")
- · Printing Material Products Division
- · Packaging Material Products Division
- Color & Display Business Group ("Color and display materials that make life colorful")
- · Color Material Products Division
- · Display Material Products Division
- Functional Products Business Group ("Functional products that add comfort")
- · Performance Material Products Division
- · Composite Material Products Division

(2) Creation of Business Planning Departments

To provide assistance in the formulation of business strategies and the realignment of product portfolios, a Business Planning Department will be established directly under each business group.

2. Establishment of the New Business Development Headquarters

New Business Planning Department, Marketing Management Unit and Product Innovation Center will be abolished. The basic research and product development functions of R&D Management Unit with these three entities will be transferred and integrated to establish New Business Development Headquarters.

3. Reorganization of the Technical Segment

With the transfer of basic research and product development functions to New Business Development Headquarters, R&D Management Unit will become an entity focused on the development of basic technologies that will underpin future competitiveness.

4. Establishment of Human Resources Strategy Department

To reinforce DIC's global human resources planning function as corporate headquarters and promote related measures, the human resources strategy function will be split off from the General Affairs and HR Department to establish Human Resources Strategy Department.
