♦Organizational Changes

[1] Shift to a global operating model (GOM)

(1) Reorganization to create a global business configuration encompassing Group companies in four operating regions

The DIC Group's current business groups—the Packaging & Graphic Business Group, the Color & Display Business Group and the Functional Products Business Group—will be reorganized to create a global business configuration that encompasses Group companies in four operating regions (Japan, the Americas and Europe, the Asia—Pacific region and Greater China), to which pertinent authority will be delegated. In line with this change, the product divisions will be renamed "business divisions." Technical and production-related divisions currently positioned as divisions within the Technical Management Unit and the Production Management Unit, respectively, will be renamed "technical centers" and "production departments," and will be transferred to the appropriate business division.

(2) Global integration of corporate functions

Individual corporate functions will be integrated on a global basis and a Group chief experience officer (CXO) will be appointed to oversee each function. In fiscal year 2026, individuals will be appointed to the positions of Group chief financial officer (CFO), Group chief technology officer (CTO), Group chief strategy officer (CSO) and Group chief human resources officer (CHRO).

(3) Realignment of the Board of Directors

With the shift to a GOM and the further delegation of authority to executive officers, consideration will be given to realigning the Board of Directors as a monitoring board. Fiscal year 2026 will serve as the evaluation period, during which time the number of directors on the Board will be reduced from the current nine to seven.

Under this newly pared-down structure, and taking into account the status of the shift to a GOM, careful thought will be given to the Board of Directors' future role. Based on the outcome of this process, beginning in fiscal year 2027 scrutiny will focus on the number of directors, the composition of the Board and whether DIC should remain a company with an Audit & Supervisory Board.

[2] Restructuring of the General Affairs and Legal Unit

A new Global HR Center of Excellence (HRCoE) will be established under the supervision of the Group CHRO. Concurrently, the HR Strategy Dept. and the Global HR Dept. will be discontinued. A new HR Unit will be created to oversee HR-related operations at corporate headquarters, while the General Affairs and HR Dept. will be renamed the HR Dept. and repositioned as a subordinate entity to this new unit.

The General Affairs and Legal Unit will be renamed the Legal and General Affairs Unit. General affairs operations, currently split between the General Affairs and HR Dept. and the Legal Dept., will be consolidated and a new General Affairs Dept. will be established within the Legal and General Affairs Unit.

[3] Creation of an independent Internal Audit Dept.

To strengthen the internal audit function, the Internal Control Dept.—currently part of the ESG Unit—will be separated out as an entity directly answerable to the president and CEO, and will be renamed the Internal Audit Dept. This depertment will be overseen by the head of the Legal and General Affairs Unit.

[4] Inauguration of the New Art Museum Preparatory Office

A New Art Museum Preparatory Office will be established within the Corporate Strategy Unit that will be responsible for various duties associated with the opening of the Group's new art museum, as well as for overseeing management of the facility where the museum was previously housed.

[5] Reorganization of the Corporate Engineering Dept., Process Development Engineering Dept., and Energy & Utility Management Group

The Corporate Engineering Dept., Process Development Engineering Dept., and Energy & Utility Management Group will be reorganized into the Corporate Engineering Dept. and the Field Engineering Dept.

[6] Dissolution of the Biomaterial Research Center

The Biomaterial Research Center will be dissolved, and its applied technology and basic technology components will be transferred to, respectively, the New Business Development Headquarters' Health Care Business Unit and the R&D Management Unit's Advanced Material Research Center.
