### **♦**Organizational changes

#### (1) Realignment of Purchasing and Logistics & Information Systems Unit

With the aim of strengthening group-wide IT and supply chain functions amidst the rapid globalization of the DIC Group, Purchasing and Logistics & Information Systems Unit will be separated and realigned into SCM (Supply Chain Management) Unit and Purchasing & Logistics Unit. With this change, Information Systems Department will be merged into SCM Unit.

#### (2) Establishment of Global IT Strategy Department

Global IT Strategy Department, which is tasked with formulating a group-wide IT strategy that will support DIC Group's medium- to long-term growth, will be newly established within SCM Unit.

#### (3) Establishment of Supply Chain Planning Department

Supply Chain Planning Department, which is tasked with building a supply chain management framework suited to DIC group's business models and supply chains, will be newly established within SCM Unit.

#### (4) Establishment of DX Promotion Department

With the objective of promoting digital transformation (DX) with a long-term perspective in a manner that synchronizes with corporate management and business strategies, DX Promotion Department will be established within Corporate Strategy Unit.
